Names that are descriptive of the business' function are difficult to register as trade marks. Without a registered trade mark your name will be vulnerable to use by others.

Tips for choosing a name that can be protected:

- Suggestive, e.g. Red Balloon is much easier to register than Online Gifts.
- Invented, e.g. Uber or Instagram.
- Unrelated, e.g. Apple is not related to computers or technology.
